

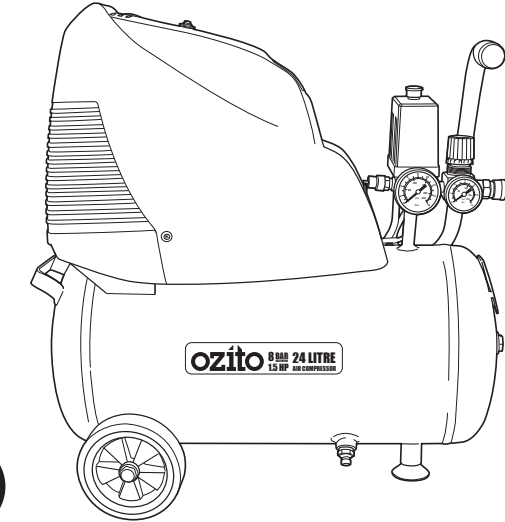

The compressor is designed for generating compressed air for tools operated by compressed air.
