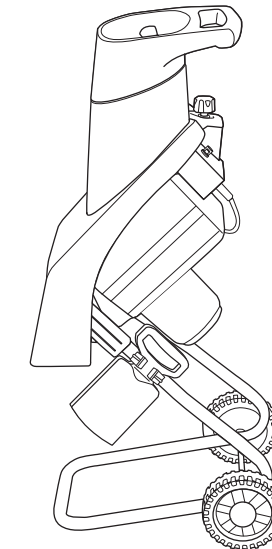

GB Additional operating & safety instructions Rapid Shredder



Important! Read the operating instructions and follow the warnings and safety instructions.



Take care when the blades are rotating. Do not put your hands or feet into openings when the machine is running.



Important! Keep other persons and animals away from the danger zone.



Important! Protect the machine from the damp and never expose it to rain.



Important! Always wear safety goggles, ear muffs, protective gloves and heavy-duty work clothes!



Always set the ON/OFF switch to OFF and pull the power plug out of the socket-outlet before doing any work on the shredder, e.g. cleaning the shredder and making adjustments, or if the power cable becomes damaged.

Items supplied

Please check that the article is complete as specified in the scope of delivery. This rapid shredder is designed only for shredding organic garden waste. Place biologically degradable material, e.g. leaves, branches, dead flowers etc., into the loading funnel inlet.

The equipment is to be used only for its prescribed purpose. Any other use is deemed to be a case of misuse. The user / operator and not the manufacturer will be liable for any damage or injuries of any kind caused as a result of this.

Please note that our equipment has not been designed for use in commercial, trade or industrial applications. Our warranty will be voided if the machine is used in commercial, trade or industrial businesses or for equivalent purposes.
