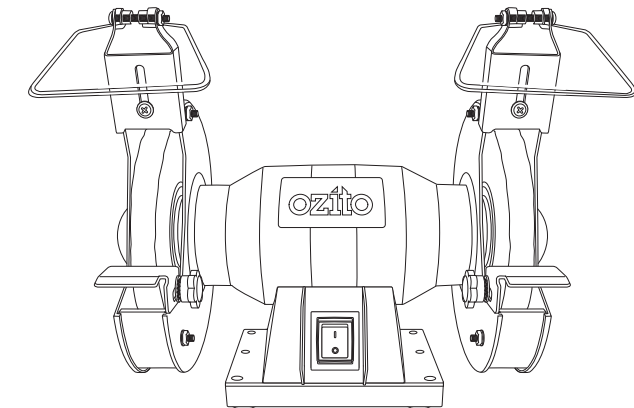

Proper use

The bench grinder is a multi-function tool for the rough and precision grinding of metals, plastics and other materials using a selection of grinding wheels.

The equipment is to be used only for its prescribed purpose. Any other use is deemed to be a case of misuse. The user / operator and not the manufacturer will be liable for any damage or injuries of any kind caused as a result of this.

Please note that our equipment has not been designed for use in commercial, trade or industrial applications. Our warranty will be voided if the machine is used in commercial, trade or industrial businesses or for equivalent purposes.

Load factor:

A load factor of S2 30 min (intermittent periodic duty) means that you may operate the motor continuously at its nominal power level (150 W) for no longer than the time stipulated on the specifications label (30 minutes ON period). If you fail to observe this time limit the motor will overheat. During the OFF period the motor will cool again to its starting temperature.
