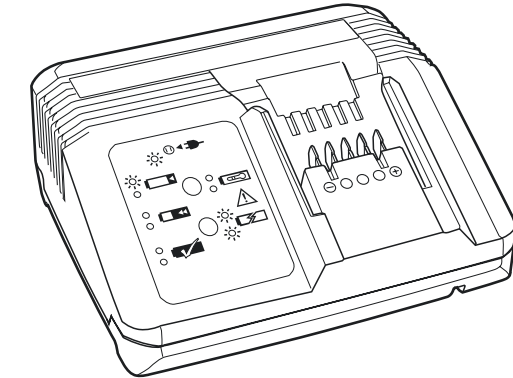

Off	Flashing	<b>Ready for use</b> The charger is connected to the mains and is ready for use; there is no battery pack in the charger
On	Off	<b>Charging</b> The charger is charging the battery pack in quick charge mode.
Off	On	The battery is 85% -100% charged and ready for use. (Charging time for 1.5 Ah battery: 30 min) (Charging time for 2.0 Ah battery: 40 min) (Charging time for 3.0 Ah battery: 60 min) (Charging time for 4.0 Ah battery: 80 min) (Charging time for 5.2 Ah battery: 105 min) <b>Action:</b> Take the battery pack out of the charger. Disconnect the charger from the mains supply.
Flashing	Off	<b>Adapted charging</b> The charger is in gentle charging mode. For safety reasons the charging is performed less quickly and takes more than 1 hour.
