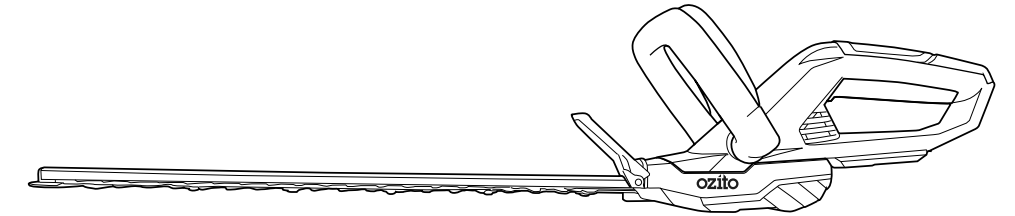

Action: Wait for the charging to be completed; you can still continue to charge the battery pack.
