Please note that the following parts of this product are subject to normal or natural wear and that the following parts are therefore also required for use as consumables.





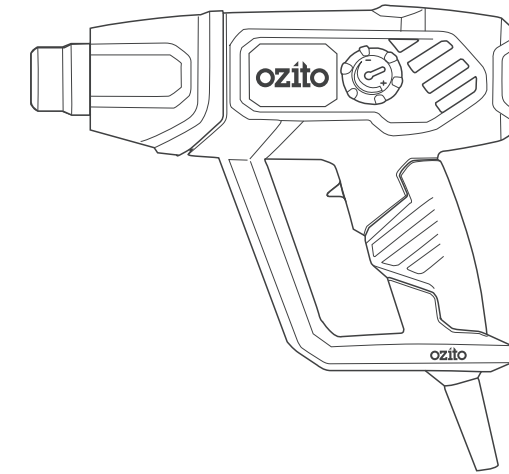

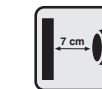
