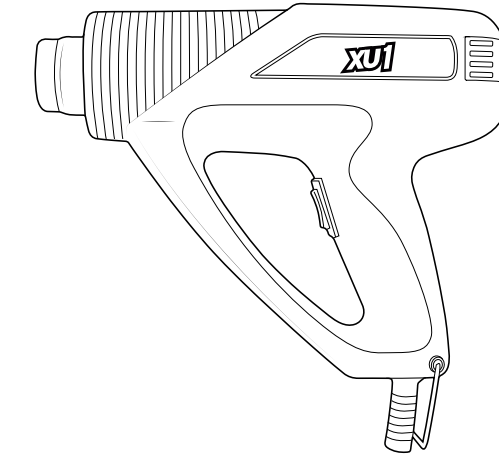

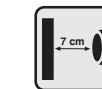

### Items supplied
